2010 Rendezvous will be held August 27, 28 and 29 at Ft Stanton. The Socorro Chapter will be the host.

SCHEDULE OF EVENTS

March 13 & 14: Cowboy Days at the NM Farm and Ranch Museum, 9 am to 5 pm both days.

We will have a booth to display pictures of our activities, brochures and membership forms, a packing demo, a Leave No Trace camp demo. We will have shade – bring chairs, come and take a turn at the booth and help get the word out about the Back Country Horsemen.

March 18: LRGC Monthly Meeting, 6:30 pm at the home of Bob & Julie Basile in Fairacres.

Directions: From the intersection of Valley and Picacho Ave. (Hwy. 70) turn West. Head West (towards Deming) on Picacho Ave and you will cross over the Rio Grande Bridge. After bridge you will cross through one stop light. Keeping heading west and look for the Fairacres Elementary School on the left.

Right after you pass the school will be North Fairacres Road, turn left. Come down North Fairacres Road 5/10 mile (look for white pipe fence on left) and turn left onto Escondido Lane. This is a dead end street and my house is the next to the last on the right: 4207 Escondido Lane. There are large willow trees just before the driveway.

Note: If you are coming from the North you can take Shalem Colony Trail and it will take you to West Picacho (Hwy 70). At the stop light make a right turn (west) on Picacho Ave. Look for the Fairacres Elementary School and follow remainder of directions above. Phone (575) 639-1569

Directions to Soledad Canyon: Take I-25 to University Exit, proceed East past the Farm and Ranch Museum, continue another three miles to Soledad Canyon Road. Turn right and follow Soledad Canyon Rd. to its end in the foothills of the Organ Mountains, about 7 miles from I-25.

April 9 & 10: Joint Work Project with Socorro Chapter and NM Wilderness Alliance at San Mateo Peak Lookout. We will camp at Springtime campground, ride to the peak and clean up the area. There is water for the horses at the campground. It is steep, rocky country, your horse should be used to the rocks and equipped accordingly. Turn left onto DeBeers Dr. and go exactly 0.3 mile. You will see a horse-crossing sign on the right, and Pat's driveway on the left. (From old HWY 185 Tel High will be the third left turn after the railroad tracks).
